## ORDINANCE NO: 2023-14

### AN ORDINANCE AMENDING WAGE RATES FOR EMPLOYEES OF THE VILLAGE OF LAKEVIEW, OHIO, AND DECLARING AN EMERGENCY

**WHEREAS**, the Council of the Village of Lakeview, Ohio passed Ordinance 2022-11 to amend Ordinance 2011-005;

**WHEREAS**, Ordinance 2022-11 needs to be amended at Section 1,

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Lakeview, State of Ohio, with a majority of its members concurring as follows:

**SECTION 1.** Section 1 shall be amended to read as follows:


Employees of the Village of Lakeview shall have the following classifications and rates of pay falling within the minimum rate and the not to exceed rate, as deemed appropriate by the Council of the Village of Lakeview, Ohio:

Electric Supervisor	\$35,000 per year	\$104,000 per year
Fiscal Officer	Minimum Wage	\$35.00 per hour
Lineman Apprentice 1	Minimum Wage	\$30.00 per hour
Lineman Apprentice 2	Minimum Wage	\$30.00 per hour
Lineman Apprentice 3	Minimum Wage	\$30.00 per hour
Lineman Apprentice 4	Minimum Wage	\$30.00 per hour
Electric Journeyman	Minimum Wage	\$30.00 per hour
Lineworker 1	Minimum Wage	\$35.00 per hour
Electric Journeyman	Minimum Wage	\$40.00 per hour
Lineworker 2	Minimum Wage	\$45.00 per hour
Electric Lead Lineworker	Minimum Wage	\$40.00 per hour
Water Superintendent	Minimum Wage	\$40.00 per hour
Street Superintendent	Minimum Wage	\$40.00 per hour
Water/Street Laborer 1	Minimum Wage	\$25.00 per hour
Water/Street Laborer 2	Minimum Wage	\$25.00 per hour
Water/Street Laborer 3	Minimum Wage	\$30.00 per hour
Water/Street Laborer 4	Minimum Wage	\$30.00 per hour
Utility Office Clerk	Minimum Wage	\$25.00 per hour
Assistant Clerk	Minimum Wage	\$22.00 per hour

**SECTION 2.** This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety, and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law.
