## ORDINANCE NO: 2025-01

AN ORDINANCE DECLARING THAT VILLAGE COUCIL SHALL MEET ONCE PER MONTH ON THE FIRST MONDAY OF EACH MONTH AND DECLARING AN EMERGENCY.

WHEREAS, currently the Village Council of the Village of Lakeview meets twice per month; and

WHEREAS, the Village Council of the Village of Lakeview is desirous to change the regularly scheduled village council meeting to one meeting per month; and

THEREFORE, BE IT ORDAINED, by the Electors of the Village Lakeview, Ohio, a majority of its elected members concurring:

### SECTION I:

Council shall meet in regular session at the Council Chambers at 6:00 p.m. on the 1<sup>st</sup> Monday of each month. Whenever the date of a regular meeting of Council falls on the following legal holidays as defined by R.C. § 1.14 (or any statute hereafter adopted by the Ohio Legislature) then the regular meeting shall be held on the Tuesday following such legal holiday.

### SECTION II: Formal Actions

That all formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting and all deliberations of this Council or any of its Committees which led to such formal actions were in meetings open to the public in compliance with all legal requirements

### SECTION III: Severability and Repealer.

If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated.

All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.

### SECTION IV: Notice

The Clerk shall cause a copy of this Ordinance be posted in a manner consistent with Ohio Law.

### SECTION V: Effective Date.

This Ordinance shall be in full force and effect at the earliest date allowed by Ohio Law.

### SECTION VI: Declaring Emergency

This Ordinance is hereby found to be an emergency necessary for the public welfare, finances, and safety due to the continued increased cost of a municipal services, costs, the continued increased cost of staff time, the increased stress upon staff for attending such meetings, to protect and provide for the Village finances, and to provide clear notice of the village council meeting dates, which are necessary for the protection of the general public health, safety, and welfare. It shall take effect and be in full force immediately upon passage.


