ORDINANCE NO: 2026-04

AN ORDINANCE AMENDING ORDINANCE NO: 2025-34 TO PROVIDE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF LAKEVIEW, OHIO, FOR THE FISCAL YEAR ENDING DECEMBER 31, 2026, AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Lakeview, State of Ohio, upon the recommendation of the Fiscal Officer and Village Administrator to make certain amendments to the appropriations made by Ordinance No: 2025-34, passed on December 1, 2025, which provides appropriations for the fiscal year ending December 31, 2026, in order to meet current expenses and to authorize certain other expenditures; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Lakeview, Ohio:

SECTION I. This Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the Village of Lakeview, Ohio. The reason for such necessity arises from the need to provide appropriations for current expenses and other expenditures for the fiscal year ending December 31, 2026, to ensure the continued, usual, daily operation of the Village Government.

SECTION II. To provide for current expenses and other expenditures of the Village of Lakeview, Ohio, for the fiscal year ending December 31, 2026, the sums contained within the below chart, as amended, are hereby appropriated.

SECTION III. Existing Ordinance No: 2025-34 is hereby amended and restated.

SECTION IV: The Fiscal Officer is hereby authorized to make payments from any of the appropriations herein made, upon receiving proper claims, certificates and / or vouchers approved by the officials, department heads, or their respective designees, authorized by law to approve the same, or upon an ordinance or resolution of Council to make expenditures; provided, however, that no payments for salaries or wages shall be made except to persons employed in accordance with the ordinances of the Village of Lakeview and / or laws of the State of Ohio.

SECTION V: The Fiscal Officer is hereby authorized to adjust appropriations within any Fund or Department, so long as the adjustments made do not exceed the total appropriations authorized within any Fund. In addition, the Finance Officer is hereby authorized to establish additional accounts within any Fund as may from time to time be required to ensure proper accounting or by the State of Ohio.

SECTION VI: It is found that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

SECTION VII: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety in the




Ordinance No. _____ Passed _____, 20____


